Here are a few of the things that CCA has accomplished on our behalf over the last for years.

CCA Played the leading role in defeating the AB3030 legislation. After that success, Governor Newsom created a 30x30 Executive Order keeping alive interests of the extreme environmental community to increase no fishing protected areas along the California coastline from the current 16% to 30%. Currently we are still in this battle as both implementing real conservation efforts and eliminating unnecessary closures remains the top priority of CCA Cal. We partnered with the American Sportfishing Association (ASA) and others to eliminate drift gillnets via successful state and federal legislation. We worked with the ASA, IGFA, Wild Oceans and others to prevent the establishment of a longline fishery off our coast. We continued to provide the primary sportfishing community leadership for the white seabass hatchery program. While halibut is still only at the experimental stages outside of Ocean Resources Enhancement Hatchery Program, "OREHP," we continue to encourage CDFW to allow hatchery halibut raised at Hubbs to be released into the wild and for halibut to become a formal part of OREHP. Pushed to have the Fish and Game Commission grant a 2 fish Bluefin tuna bag limit, instead of a complete closure. We have been working with Dr. Barbara Block by supporting her efforts to satellite tag larger Pacific bluefin in hopes of developing the actual Pacific bluefin spawning age and migratory patterns.

In addition, we partnered with SAC to ensure sardines remained available as live bait. We passed legislation to create a 365-day fishing license when others had tried and failed. We passed regulations for descending devices while rockfishing and got the cowcod conservation area opened after a 24-year closure. We stopped further bag restrictions on California halibut. We are currently playing an important role with Barred Sand Bass— a major source of enjoyment for many anglers. Just a few weeks ago CCA California worked with the Fish & Game Commissioners to avoid an in-season closure of Barred Sand Bass, and we have pledged to work with CDFW and others to help deliver accurate data collection on sand bass over the next three years.
